NCMS PAC is a voluntary, non-profit, unincorporated committee organized to direct financial support to state and federal political candidates in North Carolina. NCMS PAC membership consists of individual physicians, PAs, and students who are dedicated to preserving quality health care in North Carolina and throughout the United States. The committee is comprised of two branches, NCMS PAC-State and NCMS PAC-Federal, which together constitute the political action arm of the North Carolina Medical Society. NCMS PAC activities are funded by voluntary contributions from its members.

Voluntary contributions to NCMS PAC are not limited to the suggested amounts and should be written on a PERSONAL CHECK. Funds from corporations cannot be used for contributions and expenditures in either federal or state elections. If you are a Professional Association physician and send your contributions on a company check, such funds must be from a non-refundable drawing account established to permit draws against salary or profits and represent personal funds rather than funds of your professional association. The NCMS will not favor or disadvantage anyone based upon the amounts of or a failure to make a PAC contribution. Copies of NCMS PAC reports are filed with the Federal Election Commission and are available for purchase from the Federal Election Commission in Washington, DC. Voluntary political contributions are subject to the limitations of FEC regulations, Section 110.1, 110.2, and 110.5. (Federal regulations require this notice.) Contributions to NCMS PAC are not deductible as charitable contributions for Federal Income Tax purposes.
