Dear Provider:

On September 9, 2010, the Centers for Medicare & Medicaid Services (CMS) announced that Palmetto GBA would begin implementation of the new A/B Medicare Administrative Contract (A/B MAC) for Jurisdiction 11 (J11), which includes North Carolina, South Carolina, Virginia, West Virginia, and Home Health and Hospice services for 16 states.

Palmetto GBA is pleased to be your new contractor for the J11 A/B MAC. We are a subsidiary of BlueCross BlueShield of South Carolina and have administered Medicare health insurance services for CMS since the inception of the program in 1966. We anticipate a smooth implementation and have taken measures to minimize the effect on your day-to-day operations.

The effective date for the implementation of the J11 A/B MAC Part B North Carolina workload is **May 28, 2011**. Palmetto GBA and CMS are working together to ensure that an effective implementation occurs and access to quality service is maintained. This implementation applies to services billed on the CMS-1500 / 837B from North Carolina Part B providers currently billing CIGNA. The full implementation of the J11 A/B MAC will be completed in June 2011.

Our primary goal during this implementation is to ensure that North Carolina Part B providers receive consistent, open and clear information by:

EDI Early Boarding

Early Board with EDI now!! On March 8, 2011, EDI mailed a 'Welcome to Palmetto GBA' letter to all submitters and vendors informing them of necessary changes and procedures for enrolling in EDI that would be required during the transition period. We highly encourage all submitters to Early Board with us to ensure that you are able to transmit and receive electronic transactions, and to get accustomed to our GPNet response reports before the transition date of May 28, 2011. It is imperative that forms are

returned to us before May 13, 2011. EDI Enrollment Forms received after this date will cause interruption of EDI services.

Important Changes for North Carolina Part B Providers

A new Payer Identification number (11502) is effective May 28, 2011. You should begin to submit claims using the new Payer ID on May 28, 2011.

A new Electronic Funds Transfer (EFT) agreement is required for providers who elect to receive their Medicare payments electronically. The EFT letter and agreement were mailed on December 31, 2010. We encourage you to submit your new EFT agreement form as soon as possible. A new agreement form must be received by May 13, 2011, for your payments to continue without any delays. Failure to submit the requested form will require us to hold 100% of your payments until the new agreement form is provided.

All providers currently using any EDI service must complete and return a new Electronic Data Interchange Enrollment Form. This form is available for download from our Web site www.PalmettoGBA.com/J11B. Click on 'Implementation,' followed by 'North Carolina.' The form will be listed in the center of the page. The form must be returned to Palmetto GBA EDI by May 13, 2011, or EDI services could be interrupted. We are recollecting EDI Enrollments to ensure that we have the most current information about each provider using EDI products and services, as well as each provider's NPI, which was not included in older iterations of the Electronic Data Interchange Enrollment Form.

Palmetto GBA will begin ANSI v5010 testing for North Carolina Part B external users on June 1, 2011. No one will be placed in ANSI v5010 production until successful errata testing is completed. The ANSI v5010 testing procedures will be posted on our Web site. Please monitor our Web site for updates concerning ANSI v5010. If you have any questions, please call the Palmetto GBA Technology Support Center at (866) 749-4301.

In order to ensure a smooth implementation, CIGNA will make claims payment **EARLY** and will communicate their plans to you. Palmetto GBA will issue payments and remittance advices using normal payment cycles. We are hopeful the early payments from CIGNA will ease the implementation process for your practice. Please plan accordingly.

The Provider Contact Center (PCC) Interactive Voice Response (IVR) system and Customer Service Representatives will not be available on Monday, May 30 in observance of the Memorial Day Holiday. To successfully complete the implementation, we will be closed on Tuesday (May 31) and Wednesday (June 1). We will be available on Thursday (June 2) to assist you with your Medicare questions.
