5. Implement new strategies in the evaluation and management of the dizzy patient.

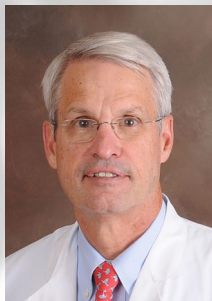
## Who Should Attend?

He is actively involved in patient care, continues to teach residents and conduct clinically relevant research.



### Anthony E. Magit, MD, MPH

Dr. Anthony Magit is a pediatric otolaryngologist who is currently a clinical professor in the ENT department at the University of California San Diego (UCSD). Dr. Magit completed his ENT residency at Duke Medical Center and a pediatric otolaryngology fellowship at Children's Hospital in Pittsburgh chaired by Dr. Bluestone. Dr. Magit has served as president of the Society for ENT Advances in Children and chief of staff at Rady Children's Hospital. He is currently Director of the Human Research Protections program for UCSD and the Medical Director for Telemedicine for Rady Children's Hospital.

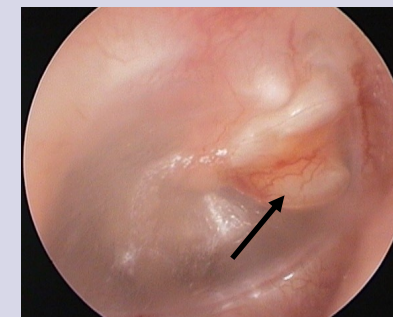
